Old Business:

1. Soccer Shed – The shed is in place and the area around it seeded. A letter will be sent to the man and his son who built it and put it in place.
2. Steiner tractor - Robert Garlin delivered the tractor to Hartman’s for the recall. The work has been done. He will be picking it up this week and returning it to the park.
3. Snapper – Mark Schoppaul serviced the Snapper. Robert Garlin will be installing the new air filter.

New Business:

1. Grant – Lynn Schoppaul spoke with Beth Helterbrand about the grant. The grant project must be finished, and inspected, by the end of May, 2010. The road crew has started work on the trails again as of the meeting date.
2. Damages to the park – The Porta-potty truck got stuck in the snow, and damaged the driveway by the handicapped parking. The damage was repaired, and the cost was paid by the company.
3. Baseball field – The ball field needs to be put back in condition, however, it won’t be fixed unless we have a team that would like to use it. Mark Schoppaul suggested we place an ad about a lonely field in need of TLC. Michael Patterson will put a post on the local leagues’ web sites.
4. Mowing – Mark Schoppaul handed out the mowing schedule.
5. Mark Schoppaul presented a To - Do list of work to that needs to be done at the park.

Public Participation: A representative from the Soccer League informed the board that the league will have all their teams at the park. The season ends June 15th. The shed has been finished.
