**Police Report:** Chief Mike Weigand gave the police report of September 13, 2015 through October 10, 2015. There were 98 calls for service, 1,927 miles patrolled, 190.5 duty hours, 1 traffic citations, 5 warnings.

Police Chief Weigand submitted quotes for body armour for the police. Woody Myers made a motion to purchase bullet proof vests at the cost of \$946.68 per vest for each police officer. Larry Dost seconded the motion and motion carried.

On October 24, 2015 there will be a Tractor Trot through Latimore Township. It will leave from Latimore Valley Fairgrounds. There are usually close to 100 tractors in this event.

Treat or Trick in the borough area of Latimore Township has been on the same day as York Springs Borough. The Borough will have their Trick or Trick after the Halloween parade on October 25, 2015 at 1:00 pm. Trick or Treat in the rest of the township has always coincided with Lake Meade Trick or Treat.
